Audiology

Through an evaluation and consultation process, our audiologists diagnose and treat hearing loss. We work with all major hearing aid manufacturers to find the best match for an individual's needs, lifestyle, and budget.

Speech-Language and Occupational Therapy

Our speech-language pathologists use evaluations and therapy strategies to improve speech and language disorders and maximize their patients' communication abilities. Our occupational therapists evaluate and treat deficits or delays in the areas of gross motor skills, fine motor skills, and sensory integration.

Community Services for the Deaf

We offer American Sign Language interpreting for individuals or businesses who have clients, patients, or students who are deaf. We also offer advocacy, monthly social events, and Community Employment Services to the deaf community.


